After notification to Agency by the Vendor of a back-order, or notification of other fulfillment delay of one or more items in a shipment, the Agency may cancel undelivered items within an order, or an order in its entirety, without penalty or charge providing the cancellation occurs before the Agency is notified that the delayed item or order has shipped.
