Delivery Information	All tire orders shall be delivered prepaid, FOB destination. Vendors will complete delivery within five (5) consecutive days after receipt of a purchase order. Vendor is to notify customer when delivery cannot be made within the five-day window.
Taxes	Vendor prices do not include applicable North Carolina sales or use tax.
Warranty	Manufacturer's standard warranty for tire type and size shall apply.
Order Placement	Orders can be placed through <u>eProcurement</u> , phone or fax. eProcurement catalogs contain all types of tires offered by each manufacturer.
Substitutions	Substitutions are not permitted without prior approval of the Division of Purchase & Contract.
