The Vendor warrants all materials and equipment related to a vehicle conversion against defects in material, workmanship and operate in accordance with all original equipment manufacturer operating standards and performance specifications. This warranty lasts for a period of three (3) years or 30,000 miles, whichever comes first, following the date the converted-vehicle was received by the purchaser.

	Dispensing System
	The Vendor warrants that all equipment furnished under this specification will be new, of good material and workmanship and agrees to promptly replace any part which by reason of defective material or workmanship fails under normal use, free of negligence or accident. This warranty lasts for five (5) years or as provided in the manufacturer's standard warranty, whichever is greater, from the date the system was put in operation. Such replacement shall include all parts, labor and transportation to the equipment, free of charge.
Compressed Natural Gas	Agencies shall obtain their compressed natural gas through the local distribution companies, <u>Piedmont</u> and <u>PSNC</u> . However, quantities requiring transportation shall be made through Statewide Term Contract <u>405N - Pipeline</u> <u>Natural Gas</u> .
