Non-mandatory entities, including schools and local governments, may use this contract as allowed by general statute.
Minimum Order	The minimum order amount that will qualify for prepaid FOB transportation is \$150.00 for a single order.
Contract Items and Pricing	Catalog Award & Pricing Information
Delivery Information	The vendor shall complete delivery to FOB destination within 14 consecutive calendar days after receipt of a purchase order. All deliveries shall be delivered to the location specified by the buyer in the purchase order. All claims for damaged or incomplete shipments must be reported within 48 hours.
Return Policy	Replacement only. The vendor will replace defective items promptly at no charge when returned within 30 days in the original packaging. The vendor does not endorse the return of goods; however, all approved returns will require a Return Material Authorization number from the vendor.
Restocking Fee	There will be a 25% restocking fee for goods due to buyer error. The goods must be returned within 90 days of the shipment date. All returned products must be sellable, unopened, in original packaging.
Taxes	Prices do not include North Carolina sales or use tax.
Order Placement	Orders may be placed through <u>eProcurement</u> , phone, or fax.
