Mandatory Contract	This is a mandatory Statewide Term Contract for state agencies, departments, institutions, universities, and community colleges – unless exempted by North Carolina General Statute. Additionally, non-mandatory entities, including schools and local governments, that are allowed by general statute may use this contract.		
Transportation Charges (FOB destination)	The minimumorderfor free shipping is <b>\$500</b> . The state will be required to use this contract for order less than the minimum order amount. However, in such cases, the order will be shipped prepaid and actual transportation charges may be added to the invoice as a separate line item. Additionally products are available for local pickup from Green Resource LLC at its Charlotte, Colfax, Garner and Supply locations.		
Packaging and Storage	All items ordered shall adhere to the following packaging and storage requirements.
