Ron Hinson's motion to approve the Committee's recommendations was seconded by John Thompson. Steve Criscenzo abstained from the vote. The selections were approved as recommended.

16. REPORTS

- a. Gordon Rutherford presented the <u>Status Report on the CM at Risk Method of Construction for</u> University Bond Projects.
- b. Gordon Rutherford presented the <u>Status Report on Nineteen Original CM at Risk Projects</u>. Mr. Rutherford also distributed a report on CM Project Distribution (Attachment 1).
- c. <u>Subcommittee on Designer Evaluations</u>: Chairman MacNaughton asked for members' comments on the evaluation forms. Greg Driver stated that the *Contractor Evaluation Form* should be corrected at the wording: "Section 322-A" to read "Section 507." A motion to approve this document, with Mr. Driver's change, was made by John Kirkland and seconded by Terry Turner. The motion was approved

<u>The Designer Evaluation Form</u> was then reviewed and formatting changes were recommended. There was some concern about the terminology "standard level of care." It was decided that a sub-group would meet to address these issues and present a revised form prior to the next

meeting to allow consideration for approval. The *Construction Manager Evaluation Form* will be modified to reflect changes made to the *Designer Evaluation Form* and also be submitted for approval at the next meeting. Interest in automating these forms and ability to retrieve information via the web continues to be a goal expressed by Commission members.

Mr. Driver stated that the *CM at Risk Evaluation Form* should be revised to include the web address to www.nc-sco.com. Sid Stone recommended that this form be revised to resemble the Designer Evaluation cover sheet.

Chairman MacNaughton distributed a revised *Designer Evaluation Form* at the meeting (Attachment 2). Greg Driver stated that the Matrix should be corrected as follows: The Schematic Design section at the wording "Section 306.1.1-4" should be changed to read "Section 306." The Design Development section at the wording "Section 307.D.1-14" should be changed to read "Section 307." At the Construction Administration section, paragraph 3, the word "observations" should be replaced with "inspections." He also stated the web address www.nc-sco.com should be added to the cover sheet.

There was much discussion by members regarding this form. Most expressed concern that it was lengthy and completing it would be time consuming. There was much support for automating the form and also that entry of ratings on the matrix would carry the scoring to the cover sheet.

Chairman MacNaughton stated that further revisions would be made to these two forms and he would email them to members for review prior to the next meeting.

- a. <u>Designer Selection Procedures for the University of North Carolina and its Constituent Institutions</u>: A motion to approve this document as presented by Gordon Rutherford was tabled at the September meeting to allow members time to review the document. A vote to accept the procedures was approved.
- b. Retainage Study Committee Report: Mr. Driver stated that apparently this report was never forwarded to the General Assembly by former Secretary Swinson. He stated he would request that Secretary Cobb forward this document.

Greg Driver informed members that the <u>State Construction Conference</u> was scheduled for February 26-27 at McKimmon Center and that additional information would be forwarded to them later.

He also stated that he would arrange for a presentation by the <u>Ethics Board</u> to update the Commission on changes in ethics laws if there was an interest. Chairman MacNaughton stated that he would poll the members to determine interest in this presentation.
