Equipment Installation	<p>Installation of items requiring custom or complex fitting or assembly efforts due to the nature of the item may be billed under the following conditions:</p> <ul style="list-style-type: none"> • The installation charge amounts have been mutually agreed upon between the vendor and the buyer in advance. • The buyer is provided an option to affirmatively accept or decline installation services at the time of ordering. • Any approved charge is listed as a separate line item on the purchase order and invoice. <p>Acceptance and approval of charges for installation of such items shall be at the sole discretion of the buyer. Any resulting damages to the item or to other state property during the installation by the vendor shall be repaired at the vendor's sole expense. General set-up activities needed to make an item ready for use shall not be considered installation and shall be included in the contract price.</p>
Delivery Information	FOB-Destination. The vendor shall complete delivery within 30 - 60 consecutive calendar days after receipt of a purchase order. All deliveries shall be delivered to the location specified by the buyer in the purchase order.
Return Policy	Replacement only. The vendor will replace defective items promptly at no charge; must be returned within 30 days in the original packaging.
Restocking Fee	A restocking fee applies in cases of buyer error; must be returned within 30 days in the original packaging.
Taxes	Prices do not include North Carolina sales or use tax.
Warranty	Standard warranty is 1-year limited parts and labor.
