#### **18. STATE CONSTRUCTION OFFICE REPORT**

Michael Shumsky provided the following updates:

- a. Golnoosh Shakibania, Antoinette Lewis and LeaAnne Hahnel have left SCO for other job opportunities. Dante Dingle will be the Administrative Staff working with the State Building Commission.
- b. There are currently six vacancies in SCO: (2) Architect II, (2) Administrative Specialist I, Business System Analyst I, and Construction Engineer II.
- c. The Construction Contract Award Letters processed by the SCO year to date is 158. As compared with 184 in 2022 and 181 in 2023 it is anticipated that SCO will process more than 200 Construction Award Contracts by year's end.
- d. The next State Construction Conference is scheduled for March 6, 2025, which is only 196 days away.

Vibha Goel provided the following updates:

a. The Design Review Section has received 1,304 plans year to date, as compared to 1,198 during 2023.

b. The Design Review Section has issued 1,299 permits year to date, as compared to 1,115 during 2023.

- c. The Design Review Section has processed 187 Exemption Projects year to date, as compared to 227 during 2023.
- d. The Design Review Section has issued 12 Tent Permits year to date.

William Johnson provided the following updates:

- a. Capital Project Management Section (CPMS) presented AGC and US Bureau of Labor Statistics data regarding national, regional, and local construction workforce negative revisions for 2023-2024 issued in July 2024.
- b. CPMS project listing and construction values of both regional (Tennessee, South Carolina, and Virginia), local (North Carolina, Raleigh) large projects that have either been placed on long-term (>4 years) or cancelled.
- c. Discussion of "funded" projects sourced from both media and government versus the above status regarding any impact to the subcontractor bidding environment on State capital projects.
