Chair Zena Howard: Ginger Dossier (Governor Appointee) offered her resignation last week. The Governor's Office has been notified and is working on a new appointment

14. STATE CONSTRUCTION OFFICE REPORT

Michael J Shumsky, PE provided the following updates:

- ➤ Since the beginning of the year, the Design-Review section has received 888 projects, and the number of response letters sent out has been 831, 156 exemption projects, and 25 tent permits.
- ➤ The 2023 State Construction Conference is scheduled for March 2, 2023. Solicitation for the State Building Commission Certificate of Merit Awards Program will be sent within the next month. Based on the criteria, nominations will be due by December 31, 2022. Award winners will be announced during the State Construction Conference.
- The State Construction Office is working on Office State Budget Management for the Fiscal Year 2022-2023 Repair and Renovations (R&R) request for NCDOA projects. SCO is also reviewing and approving OC-25's (Cost Estimates) for other state agencies. The R&R request submission deadline for all agencies is October 14th.
- > The State Construction Office has partnered with the NCDOT Aviation Division for drone training. SCO purchased a drone for use by the Facilities Condition Assessment Program (FCAP) and Electrical Inspectors.

Robert Tally, PE provided an update:

Agencies can resubmit a Repair and Renovation request from January 2022 (provided there are no changes in the scope of the project) that was not funded in the last round of R&R with an increase of up to 12% for construction and an additional 12% for escalation without needing to get the OC-25 (Cost Estimate) updated by the State Construction Office.

William Johnson, RA provided an update:

- ➤ Updated the DHHS Campus Phases 2 and 3 projects: DOA Evaluation Committee interviewed four (4) developer teams last week, and selected Highwoods Properties of Raleigh to be our Private Public Partnership (P)3 developer partner for Phases 2 & 3 of the 34-acre site, which is anticipated to be 2.2 million square feet of mixed-use development on Blue Ridge Road in Raleigh.
- ➤ DOA advertised for design firms on September 26, 2022, for the demolition and site stabilization of the Bath Building in Raleigh. Proposals are due to the State Construction Office on Monday, October 17, 2022.
