# Supplemental Internal Audit Services – 8411A

Effective Dates: November 2, 2023 – November 1, 2028

The Division of Purchase & Contract is facilitating a **rolling** award for a new statewide term contract for supplemental internal audit services. Information on the awarded vendors will be updated as and when additional vendors are awarded.

This is a mandatory statewide term contract for state agencies, departments, institutions, universities, and community colleges, unless exempted by North Carolina general statute. Additionally, non-mandatory entities including schools and local governments that are allowed by general statute may use this contract.

#### **New Contract Highlights**

This contract replaces previous statewide term contract 946C.

This STC covers services for the state's need of pre-qualified vendors for:

- Supplemental Internal Auditing
- Assurance
- Accounting
- Managerial Advisory Services

All services require the pursuit of a subsequently issued request for quote, detailing the scope of work, to be further competed by at least two (2) awarded vendors on an as-needed basis.

#### **State Agencies**

Currently there are six (6) awarded vendors offering services for projects that maintain data security using state infrastructure (on premise).

**IT Component Alert** – This contract contains DIT policy-driven components to which state agencies are required to adhere.

### Universities, Community Colleges, and All Non-Mandatory Entities

Currently there are nine (9) awarded vendors offering services for projects not associated with state DIT policy requirements.

All awarded vendors have a dedicated account representative for the placement of orders to ensure agencies receive the utmost level of customer service.

The Division of Purchase & Contract is focused on establishing statewide term contracts that provide customers with goods and services at the best value.
